Discipline Policy

St. Marguerite d'Youville Academy creates an atmosphere of charity within the educational process. Therefore, discipline is part of maintaining this atmosphere, both in relationship among one another and in individual development. In disciplining, we will always try to discipline with charity and justice.

SMDA School Rules

These general school rules are to be followed at all times while in the school building and at sporting or academic events where the school is represented.

- Be respectful to all
- Practice safety
- Be cooperative
- Listen and follow all teacher directions
- Raise hand and wait to be called upon before answering
- Work independently without disturbing others
- Remain in seat until permission is given to get up
- Accept corrections well
- Never leave the classroom without permission
- Stand up to greet Priests, Sisters, the Principal and other visitors when they come to your classroom
- No gum
- Be a good team player by following the game rules

Classroom Consequences and Intervention Ideas

- Each teacher will keep a record sheet of school rule infractions on every child.
- Each teacher should keep the principal informed of the classroom offenses.

1. First time offense:

The teacher and child meet privately.

The child repeats the rule that was not followed.

The child tells what they can do to improve.

The child apologizes if needed.

- Ask the offending student, "What's the rule?" If student cannot answer, repeat it calmly.
- Ask the student if he/she understands the rule.
- Ask the student if he/she can follow the rule.
- Say, "Thank you."
- Student should apologize.

2. Second time offense:

Follow guidelines stated at step one above.
The child repeats the rule not followed.
The child tells how they plan to improve their behavior.
Teacher gives the child a time-out.

- Student should have time out during recess time.
- Suggested time out: 10-15 minutes.

3. Third time offense:

- Follow guidelines stated above at steps one and two.
- Repeat the rule not followed.
- Student fills in the behavioral plan for improvement form.
- Discuss it with teacher and principal.
- The written behavioral plan goes home to parents for signature. Should be returned to classroom next day.
- If note is not returned or signed, call parents.
- Child eats lunch in principal's office.
- Time-out during recess time.
- Suggested time out- 30 minutes

4. Fourth time offense:

- Follow guidelines stated above at step three.
- Student goes directly to principal's office.
- Child writes a plan to improve behavior on the behavioral plan form.
- Parents are called in for a conference to discuss seriousness of the problem(s).
- No recess time.
- Time out in the principal's office
- Child eats lunch in principal's office
